
## CONSTITUTION OF GRIEVANCES REDRESSAL COMMITTEE

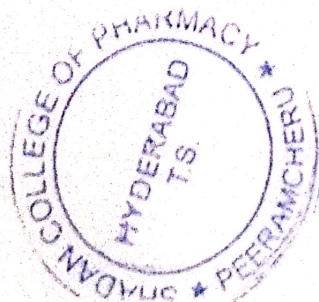

All the Students, Their Parents, and other public may approach the Grievances Redressal Committee (GRC) for any type of Grievances. "Grievances" include the following complaints of the aggrieved students, namely:

1. Making admission contrary to merit determined in accordance with the declared admission policy of the institute.
2. Irregularity in the admission process adopted by the institute.
3. Refusing admission in accordance with the declared admission policy of the institute.
4. Non publication of prospectus, as specified.
5. Publishing any information in the prospectus, this is false or misleading, and not based on facts.
6. Withhold or refuse to return any document in the form of certificates of degree, diploma or any other award or other document deposited with it by a person for the purpose of seeking admission in such institution, with a view to induce or compel such person to pay any fee or fees in respect of any course or program of study which such person does not intend to pursue.
7. Demand of money in excess of that specified in the declared admission policy or approved by the competent authority to be charged by such institution.
8. Breach of the policy for reservation in admission as may be applicable.
9. complaints of alleged discrimination of students, from the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Women, Minority or Disabled categories.
10. Non-payment or delay in payment of scholarships to any student that such institution is committed, under the conditions imposed by University Grants Commission, or by any other authority.
11. Delay in conduct of examinations or declaration of results beyond that specified in the academic calendar.
12. On provision of student amenities as may have been promised or required to be provided by the institution.
13. Denial of quality education as promised at the time of admission or required to be provided.
14. Non transparent or unfair evaluation practices.
15. Harassment and victimization of students, including sexual harassment.
